We use your data to:

- deliver the Agent's responses and maintain the system
- monitor and improve performance and safety
- respond to legal or regulatory requests where applicable

## **c. Data Sharing**

We may share data with:

- third-party AI service providers we engage to process messages
- the underlying Platform (A0X) or integrated platforms (Base, Telegram, etc) as required for functionality
- authorities if legally compelled

We do **not** sell your personal information.
